The business to be acted upon at said Special District Meeting shall be as stated in the Notice thereof; and the District Clerk is hereby authorized and directed to cause the Notice of said Special District Meeting to be published in The East Hampton Star and Press two newspapers each having a general circulation within the District, such publications to be at least once in each week within the two weeks next proceeding such Special District Meeting.

Section 3. All other dates and times as more fully set forth in such Notice are hereby approved by the Board of Trustees.

BE IT RESOLVED, that the Board of Trustees appoint Norma Bushman as the chairperson and poll clerk. Seth Calero, Abigail Fleming, Reghan Anderson, Calum Anderson and Nancy McCaffrey as inspectors. Seth Calero will serve as translator of the District's Board of Trustees Election and Budget Revote to be held on June 20, 2023 from 2:00 pm – 8:00 pm. Mr. Calero and the inspectors will be paid at a rate per hour to be determined by the Superintendent.
